#### **Description of necessary first aid measures**

Eye contact

### **Small spill**

### : Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. #### Large spill

# Appropriate engineering controls
