## Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

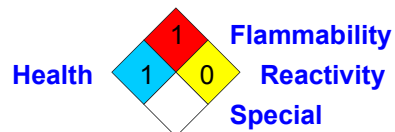
